- **Dwight Eisenhower** — Fred Greenstein's "hidden-hand" thesis: Ike refused to attack McCarthy publicly but orchestrated the Army's counteroffensive and the Executive Privilege order (May 1954) that cut off McCarthy's access to executive-branch witnesses.
- **Edward R. Murrow and Fred Friendly**, *See It Now*, "A Report on Senator Joseph R. McCarthy," CBS, March 9, 1954. Thomas Rosteck's monograph treats the four McCarthy-related broadcasts as rhetorical texts; Thomas Doherty argues more broadly that television, far from being McCarthyism's handmaiden, was structurally hostile to it.
- **Joseph N. Welch**, Army counsel, Army–McCarthy hearings, June 9, 1954 ("Have you no sense of decency?"). The hearings' 188 broadcast hours are the pivot point in almost every account; Emile de Antonio's compilation documentary *Point of Order* (1964) later fixed them in cultural memory.
- **Ralph Flanders** (R-Vermont) introduced the censure resolution (July 1954); **Arthur Watkins** (R-Utah) chaired the select committee; **Lyndon Johnson**, as minority leader, engineered the Democratic bloc vote and kept the process procedurally boring — Robert Caro's *Master of the Senate* has the fullest narrative. The Senate "condemned" McCarthy 67–22 on December 2, 1954. **J. William Fulbright** had cast the lone vote against McCarthy's subcommittee appropriation earlier that year.

Phase 2 — Courts and Congress dismantle the machinery (1955–1977)

- **The Warren Court.** *Slochower v. Board of Education* (1956), then "Red Monday," June 17, 1957 — *Yates v. United States*, *Watkins v. United States*, *Sweezy v. New Hampshire*, *Service v. Dulles* — gutting Smith Act prosecutions and reining in HUAC-style inquiries. Hugo Black's 1951 *Dennis* dissent had predicted the Court would reverse itself "in calmer times," which is Arthur Sabin's title. Key justices: **Earl Warren, Hugo Black, William O. Douglas, William Brennan**. Robert Lichtman's book is the essential caution here: congressional backlash caused the Court to retreat, with Felix Frankfurter leading a five-justice majority that effectively nullified earlier decisions (e.g., *Barenblatt*, 1959), and only after Frankfurter's retirement and Arthur Goldberg's arrival in August 1962 did the Court again consistently vindicate individual rights in "Communist" cases. *Albertson v. - **HUAC's decline.** The May 1960 San Francisco City Hall protests, and HUAC's own propaganda film *Operation Abolition* (which backfired on campuses), marked the committee's loss of legitimacy. **Frank Wilkinson's** National Committee to Abolish HUAC (1960) led the campaign; HUAC was renamed the House Internal Security Committee in 1969 and abolished in January 1975. The Senate Internal Security Subcommittee followed in 1977.
- **Executive branch.** Nixon's Executive Order 11785 (1974) abolished the Attorney General's List of Subversive Organizations, the administrative backbone of the loyalty program since 1947. Robert Justin Goldstein's *American Blacklist* (University Press of Kansas, 2008) is the monograph on the list.
- **Oppenheimer.** The 1954 revocation of J. Robert Oppenheimer's clearance was symbolically reversed with the Fermi Award (announced by Kennedy, presented by Johnson, December 1963) and formally vacated by the Department of Energy in December 2022 — a good example of how long "restoration" can take.

Phase 3 — The culture industries break the blacklist (1960–1976)

- **Dalton Trumbo**, screen credit on *Spartacus* (Kirk Douglas) and *Exodus* (Otto Preminger), both 1960 — the conventional "end" of the blacklist. **John F. Kennedy** publicly crossed an American Legion picket line to see *Spartacus* in February 1961.
- **John Henry Faulk v. AWARE, Inc.** (1962). The CBS radio host, represented by **Louis Nizer**, won a \$3.5 million libel verdict (reduced on appeal) against the blacklisting outfit run by Vincent Hartnett and Laurence Johnson. Faulk's memoir *Fear on Trial* (1964) became a CBS TV film in 1975 — itself a sign that the networks were ready to dramatize their own complicity.
- **Pete Seeger** returned to network television on *The Smothers Brothers Comedy Hour* (1967–68) after a 17-year ban; CBS's censorship of "Waist Deep in the Big Muddy" made the episode a cause célèbre.
- **Ring Lardner Jr.** (Hollywood Ten) won the screenplay Oscar for *MASH** (1970) under his own name; **Waldo Salt** for *Midnight Cowboy* (1969).
- **Charlie Chaplin's** honorary Oscar and return to the U.S. (1972).
- **Woody Allen / Martin Ritt / Walter Bernstein**, *The Front* (1976), made by blacklisted and closing on their names and blacklist dates; **Lillian Hellman**, *Scoundrel Time* (1976), which triggered the still-running argument about

the memoir's accuracy. Victor Navasky's *Naming Names* (1980) reframed the era around the moral problem of the informer.

- **Credit restoration.** The Writers Guild restored blacklist-era credits in waves from the 1980s on (Trumbo's *Roman Holiday* story credit, 2011). **Elia Kazan's** 1999 honorary Oscar — with Nick Nolte and Ed Harris pointedly not applauding — showed the wounds were still open; Jon Lewis's *Cinema Journal* article opens with that scene. *Good Night, and Good Luck* (2005) and *Trumbo* (2015) are the canonical late retellings.
